The Blackburn EDZ BID End of Year Report highlights the key initiatives and successes delivered over the past 12 months, along with our plans for the year ahead.



What We Delivered in 2023/2024

Theme One – Security and Crime Prevention

- ✓ Proactive monitoring of the 28-camera CCTV system to ensure it remains robust, reliable and fully operational. We've increased CCTV signage across the estate, further deterring unwanted activity and providing businesses with peace of mind.
- Launched the Rapid Text Alert System, providing real-time intelligence on incidents across Greenbank, Furthergate and Whitebirk. To date, 50 businesses have signed up to receive immediate updates on suspicious activity or crime. Simply call 0333 121 0393 to register or send a Rapid Text.
- Held monthly meetings with the neighbourhood policing team, ensuring businesses can report concerns, discuss challenges and connect with local officers for advice and support.
- Attended Lancashire Partnership Against Crime (LANPAC) meetings to stay ahead of emerging trends and ensure businesses remain informed about local and regional security developments.
- Kept businesses updated through regular B2B newsletters, offering news, guidance and BID updates to support day-to-day operations.

Blackburn EDZ BID has made significant strides in community safety through its CCTV initiative, aiding in 95 incidents from January to December 2024.

This achievement underscores the vital role of surveillance in enhancing local security. Visual updates, including a comparison of the area before and after hedge maintenance, are in progress to further illustrate these efforts.

What We Delivered in 2023/2024 (Continued)

Theme Two – Image Enhancement, Cleaner and Greener

- The BID's Green Team continued to deliver an enhanced litter-picking service across the EDZ, removing 2,260kg of waste from estate boundaries, shrubbery and communal areas.
- Tackled hotspot areas proactively by installing targeted signage to deter littering and improve the overall appearance of the area.
- ✓ Worked with Blackburn with Darwen Council to ensure public spaces remain clean and well-maintained. Over the year, we reported and resolved 60+ maintenance issues, including potholes, street lighting and damaged infrastructure.
- Addressed 32 incidents of fly-tipping, working quickly to report and coordinate removal with the local authority to ensure minimal disruption to businesses.
- Refreshed and revitalised the large directional signage across the EDZ with modern, professional designs to reflect the estate's commitment to security, connectivity and business pride.





Theme Three – Business Support, Recruitment and Net-Zero

- Delivered one-to-one engagement with
 86 businesses, listening to challenges, offering tailored advice and ensuring businesses benefit from BID-funded services.
- Welcomed new businesses with Welcome Packs, introducing them to the Blackburn EDZ BID and providing information on how they can access support.
- Provided regular updates through newsletters and emails, including funding opportunities, grants and success stories that celebrate our local businesses.
- Partnered with specialist providers, including BOOST Lancashire and Training 2000, to offer recruitment support and promote workforce development services.
- Supported businesses on their Net-Zero journey by hosting workshops and offering one-to-one sessions with sustainability specialists to help businesses reduce carbon emissions and plan for a greener future.
